Rural Transformation Grants Awarded Locally

The second round of award recipients of the Rural Transformation Grant were released on December 14, 2022. A total of 42 rural local governments in North Carolina were recipients of funds made available through the American Rescue Plan (ARP). Funding totaled \$19.76 million and categories included: Downtown Revitalization, Resilient Neighborhoods, Community Enhancements for Economic Growth, and Rural Community Capacity Building. Within the Kerr-Tar Region, both **Franklin County** and the **Town of Louisburg** were awarded \$450,000 each for Community Enhancement. At their December 1, 2022 meeting, the Golden LEAF Board of Directors selected Warren County for SITE Identification support through its new SITE Program. The SITE program provides support to communities to identify potential sites for economic development, and enable completion of due diligence on sites already identified, or to extend public utilities to or conduct rough grading and clearing of sites for which due diligence has been completed. Warren County was the only community selected to receive assistance through this cycle of the SITE Program. "The Golden LEAF Board of Directors

established the SITE Program to help rural communities make sites available for development to attract new businesses and create opportunities for existing businesses to expand," said Scott T. MAYOR OF MACON

Macon Mayor Carroll Harris, a United States Air Force veteran, strives to live a life defined by a desire to help his community, whether that refers to the people of Macon, or his service to his country during the Vietnam War. His drive to serve his community in both the smaller and broader sense extends beyond his service in the Air Force and his career. Harris has served his home town of Macon for more than 30 years. He was chairman of the board of elections for Macon, and was later elected to the town's board of commissioners in 1981. Harris served on the board for 18 years and was elected mayor in 1999. He served in that capacity until 2007, and took a six-year break before being elected mayor once again in 2015.



"I try to help the town in a lot of ways," Harris says. That work to help the town includes tasks such as mowing grass, trimming shrubs and putting up Christmas decorations. "I'm trying to give back to the community," "I'm proud of the town." Read more about Mayor Harris [HERE](#).

Updated National Broadband Map

In November of last year, the Federal Communication Commission (FCC) unveiled its new Broadband Availability Map. Along with a new map style, the FCC also introduced a **challenge process** that allows everyone - from governments to citizens - the ability to highlight false claims of availability and ensure that every home and business location is accounted for in the map.



Local governments interested in submitting a challenge regarding the updated FCC broadband map should submit location challenges by **Friday, January 13, 2023**. In an effort to provide a better understanding of the map itself, and the challenge process, the Institute of Local Self Reliance has created a **short series of instructional videos** and a **click-through guide** on how to file location and availability challenges to the FCC's new Broadband Availability Map.

Adoption of 2023-2027 CEDS



On December 1, 2022, the Kerr-Tar Board of Directors formally adopted the region’s Comprehensive Economic Development Strategy Plan (CEDS) with the assistance of Sanford Holshouser Economic Development Consulting and Dancy Research. This process involved the formulation of a diverse CEDS Stakeholder Committee; individual county-led Focus Groups; and citizen surveys. The Plan is well formulated, following current EDA guidelines and we look forward to working with federal, state and local stakeholders on accomplishing many goals and objectives throughout the next five years. Ethics Filing Reminder

Elected officials and appointed alternates serving as members of the KTRPO TAC are required to submit Statements of Economic Interest (SEI) and Real-Estate Disclosure (RED) Forms annually to the North Carolina State Ethics Commission. The annual due date for the Commission to receive these documents is **Monday, April 17, 2023**. Mobility for Everyone, Everywhere in North Carolina



In up to 11 rural communities across North Carolina, USDOT is investing \$10.4 million in new and expanded on-demand transit services that will be tailored to each community’s unique transportation needs. The project will increase economic opportunity and improve the quality of life for local residents. **KARTS (Kerr Area Transportation Authority)** is among those transit services. Warren County CERT Seeks Community Volunteers

Announcing 2023 Granville County Recreation Mini-Grants

The Granville County Parks, Greenways, and Recreation Advisory Committee is accepting applications for the **2023 Recreation Mini-Grant**. The application period will close on **January 31, 2023 at 3:00 p.m.** Applicants must be a government entity or a non-profit organization. While those interested in applying for these funds do not have to be a registered 501c-3, it is encouraged.

Gateway Invites Applications for Downtown Revitalization Grants

Gateway Community Development Corporation, located in Henderson, is offering grants to local businesses to make needed improvements. Downtown businesses have an opportunity to get financial assistance in sharpening their appearance or in upgrading their technology capability. Gateway received a \$25,000 Hometown Revitalization grant to be used in making microgrants to local businesses. Gateway's President, Heather Joi Kenney said, the organization will award microgrants ranging in size from \$500 to \$2,500, depending on the scope of the work to be undertaken

Applications Open for NCDOT Bike Helmet Initiative

Since being introduced, the North Carolina Department of Transportation's Bicycle Helmet Initiative has equipped thousands of children with a helmet. Unfortunately, children are a key demographic involved in bicycle-related incidents. To promote helmet usage and support local bicycle activities, the Division of Bicycle & Pedestrian Transportation is accepting applications from organizations and non-profits willing to distribute helmets to children. The selection process encourages applicants to collaborate with community groups to extend bicycle safety awareness outreach.

The application deadline for 2023 is **Friday, February 3**. Interested organizations are encouraged to apply [HERE](#). Once distributed, the KTRPO will gladly provide assistance as a regional partner with the distribution of helmets and other safety materials.



Carbon Reduction Program

The Bipartisan Infrastructure Law (BIL) established a new funding opportunity for projects to reduce carbon dioxide emissions from on-road highway sources. NCDOT's Transportation Planning Division (TPD) is administering the funds for the rural areas of the state. Each RPO can submit up to 12 projects to TPD for scoring and selection. Municipalities, county governments, tribal governments, and public transit agencies are eligible to apply. The minimum project cost is \$100,000 and a 20% local match is required in most cases. Examples of eligible projects include but are not limited to:

NCDOT Paved Trails & Sidewalk Feasibility Grant Program

The N.C. Department of Transportation (NCDOT) has established a new **Paved Trails and Sidewalk Feasibility Study Grant** program to evaluate proposed paved trails, greenways, sidewalks and side paths. Feasibility studies examine the viability of a transportation project, complete initial stages of design and environmental review, and develop implementation strategies. The feasibility study further enables communities to examine route alternatives, develop cost estimates, and advance projects to compete for additional funding for design and construction.



Those eligible to apply include North Carolina municipalities, counties, metropolitan or rural planning organizations, bicycle, pedestrian advocacy, and trail friend groups, as well as land conservancies. The grant call is currently **open until January 9, 2023.**

First Day Outdoors: North Carolina Year of the Trail 2023

The Great Trails State Coalition is gearing up for **Year of the Trail** with their **First Day Outdoors** campaign.

First Day Outdoors welcomes North Carolinians to include a trail experience in their New Year's Day activities, document it through photos or video and share across social media platforms (hashtags **#greattrailstate**, **#greattrailinc**, **#yearofthetrail**).
